Woman's Missionary Society – Update

In May, I was very privileged to be selected as the delegate to represent Vancouver Island Presbyterial to attend the Annual Council Meeting held at Crieff Hills Community, Ontario. The facility hosting the council meeting had an open and welcoming feel to it which accented the friendly atmosphere generated by delegates attending to share their fellowship, knowledge and focus toward the goals of the Missionary Society. The fact that delegates came together from all communities and congregations across this great country made it a very special and uplifting experience. In groups, we were encouraged to share experiences, stories and individual congregational goals. This fostered a sense of community amongst delegates, and stimulated discussions on a wide variety of Christian ideals. The main speakers were missionaries from India, Ukraine and Nigeria. They were as follows:

- Pauline Brown from India emphasized the Jobat Christian School and the training/support of the nurses toward the Bhil people.
- Rev. Arlene Onuoha from Lagos, Nigeria centered in on reaching the goal set out by operation 'plant a church' whose aim is to create a functional parish within a year.
- David and Anna Pandy- Szekeres from Ukraine, which also incorporates other Eastern European countries, focused on the necessity to educate the young particularly the gypsy children who are often ostracized in that culture.

I found these reports to be interesting, eye opening as well as thought provoking. The mission is doing incredible work globally, on an individual, parish, and Synodical level. It is amazing to see what these people can do with what we would consider next to nothing. On our worst days, we are very blessed and should reflect on our abundance.

If you are interested in supporting this worthwhile society ask me about it. This year the Afternoon Group is studying Guatemala.

THE SCOTT WOODS BAND

This 5 piece band of multitalented musicians will play old time fiddle music as well as traditional country and gospel. Scott plays several instruments as do others in this band which was featured in the October 2006 edition of the Presbyterian Record. However his favorite instrument is the fiddle which he has been playing since age four from classical to big band, Celtic to country. Scott has captured all the major Canadian fiddling titles. For seven years he was the musical director and played the part of Don Messer in 'Memories of Don Messer's Jubilee', a tribute show which toured across the country. His father Mervyn was an original Don Messer fiddler. His mother Caroline on piano, brother Bruce-fiddle and drums are also mainstays of this band. Guitarist/vocalist Ivan Felker and Karl Watson- bass player, complete the basic unit. Sister Kendra Norris-fiddle joins them as able.

The Scott Woods Band which has performed to enthusiastic crowds across Canada, the USA and Holland is accustomed to sell out performances. Plan early and don't miss this upbeat and uplifting concert!!

INSIGHTS FROM THE STEWARDSHIP COMMITTEE

The Stewardship Committee of Knox Church has learned amazing things in the two years since its formation. We would like to share some of what we have discovered with each of you.

- We have learned to look at giving in a different way and to understand why it is we give.
Therefore, each member of the committee is a regular, intentional and generous giver.
- We have learned that there is a philosophical gap between our committee and some of the leaders at Knox.
Therefore, we have had to rethink our methods of promoting financial stewardship within the congregation.
- We have learned that people give to people and that everyone in the congregation needs to have a sense of community.
Therefore, we would like to promote relationships within the congregation, beginning with the Elder groups, to work toward ensuring that everyone has a feeling of belonging.
- We have learned that growth in community will come about only through strong leadership.
Therefore, we would encourage the leadership of Knox to be in regular and intentional contact with those in their Elder group and to promote contact within that group.
- We have learned that growing community leads to growth in worship – something more important than growing membership - worshipping people give.
Therefore, we would encourage the leadership of Knox to be in regular and intentional attendance at worship service.
- We have learned that giving is our response to God's abundant gifts to us.
Therefore, we encourage the leadership of Knox to personally and prayerfully consider God's abundant gifts and to consider what his or her appropriate response should be.
- We have learned the importance of providing different opportunities for people to give.
Therefore, we encourage and support:
 - *Annual giving through the envelope and PAR systems, that provide methods of giving regularly and intentionally;*
 - *Spontaneous gifts, such as the offerings at the evening services, offerings that are allocated for specific purposes;*
 - *Major projects, such as the offerings for the piano;*
 - *Planned gifts, such as the annuity received from Eileen Mossop in 2006.*

In cooperation with Knox Session and the Board of Managers, members of the Stewardship committee are committed to building on Knox's strengths and to encouraging the motivations of compassion, community and hope. We are committed to the goal of having the congregation of Knox living as a family, a movement, a true Christian congregation. We look forward to your continued support and participation.
